1. Attention is invited to the orders issued in the reference third cited, in which orders were issued directing all the Secretariat Departments and the Heads of Departments to furnish unit wise data relating to sanctioned cadre strength of the local, district, Zonal, Multizonal and state cadre post and all the posts in Heads of Department and state level office. Instructions were also issued to furnish data of employees working in the state cadre post in all departments and for all the posts in the Secretariat, HoD and other state level offices, before 31st March, 2014. The last date for furnishing the data online was subsequently extended upto 12th April, 2014, in the reference fourth cited.

2. This information is urgently required by the Govt. of India for action under section 77 (I) of the AP Re-organisation Act and for allocation of posts and personnel to both successor states has per the provisions of the said Act. It is absolutely essential that the data has to be furnished immediately.

3. A review meeting was convened on 22 April, 2014 and all the Secretariat departments and HoDs were requested to complete the work by 25th April 2014 positively.

4. Notwithstanding the time – sensitive nature of the work and its critical importance to the reorganization work, some of departments have not furnished complete data so far. The details of the work done by these departments is given in the annexure to this memo

5. Therefore, it is proposed to review the progress of work with the Heads of Departments mentioned in the annexure at 11.00 AM to 1.00 PM on 28th April, 2014 in the conference Hall, at Dr. Marri Channa Reddy Human Resource Development Institute of Andhra Pradesh. All the Nodal Officers of the departments concerned are requested to attend this meeting with the following information:

1. Total Number of sanctioned posts of each category and the vacancies in that category.
2. A list of employees working in all categories in the offices of the Heads of Departments, state level offices and the state cadre posts in the orders of Seniority.
3. The details of the Contract and Outsourced personnel working in the department for each category.

4. The Special Chief Secretary / Principal Secretary / Secretary of the department are requested to ensure the participation of concerned officers.
