Sub: A.P. Reorganisation Act 2014 -Tentative allocation lists of State cadre employees - Admitting the employees working in one State tentatively allocated to the other State -Clarification -Reg

In the Circular Memo cited it has been clarified that the following categories of tentatively allocated employees are not to be relieved till final allocation orders are issued by Central Government:

- a. The tentatively allotted employee who is aggrieved by his/her tentative allotment and represented within the prescribed period of two weeks from the date of publication of notification against his/her tentative allocation.
  - b. The tentatively allotted employee against whom there are objections made within the prescribed period from the date of publication of notification on his/her tentative allotment.
  - c. Only those representations/ objections received within the prescribed period of two weeks from the date of publication of the notification to be considered in respect of the above two categories of cases for withholding the relief of the tentatively allotted employees.
2. Instances have come to the notice that certain tentatively allotted employees to either of the States, who are aggrieved and represented against their tentative allocation or on whose tentative allocation there are objections by others, are relieved contrary to the instructions/clarification issued in the Circular Memo cited.
3. All the Departments of Secretariat and Heads of the Departments of both the States of Andhra Pradesh and Telangana State are therefore requested not to admit such tentatively allotted employee who is relieved contrary to the instructions/clarification issued in the Circular Memo cited. They are requested to send such employee back to the State from where he/she is relieved.

4. All the Departments of Secretariat and Heads of the Departments of both the States of Andhra Pradesh and Telangana State are requested to adhere to the instructions/ clarification issued in the Circular Memo cited scrupulously.
