The Andhra Pradesh Reorganisation Act, 2014 – Provisional allocation of Buildings in Greater Hyderabad Municipal Corporation Area for the Legislative Assembly, Legislative Council, Camp Office-cum-Residence of Chief Minister, Residence of Ministers, MLAs and MLCs of the successor States of Andhra Pradesh and Telangana– Orders – Issued.

ORDER:

- 1. In the Gazette first read above, the Government of India has notified the Andhra Pradesh Reorganisation Act, 2014 (Act No.6 of 2014). In the Gazette second read above, in exercise of the powers conferred by section 2(a) of the said Act, the Central Government has notified the 2ndday of June, 2014 as the Appointed Day for the purposes of the Act.
- 2. As per section 5 of the Andhra Pradesh Reorganisation Act,2014 (Central Act No.6 of 2014), on and from the appointed day, Hyderabad (Greater Hyderabad Municipal Corporation Area) shall be the common capital of the State of Telangana and the State of Andhra Pradesh for such period not exceeding ten years. In this background, the buildings in GHMC area are to be allocated for the Legislative Assembly, Legislative Council, Chief Minister's Camp Office, Ministers' Residence; and MLAs' and MLCs' Quarters of the successor States of Andhra Pradesh and Telangana.
- In this context, the Government established a sectoral Committee for making 3. appropriate recommendations for allocation of government buildings between the successor States, chaired by the Special Chief Secretary to Government (Transport), with the Principal Secretary to Government, R&B; the Principal Secretary to Government, Revenue; the Metropolitan Commissioner, HMDA; and the Commissioner of GHMC as Members. Further, in the reference third read above, the Government constituted a Special Committee, chaired by the Special Chief Secretary to Government (Transport), with the Principal Secretary to Government (R&B); the Principal Secretary to Government, Irrigation(Project); the Secretary to Government, GAD (Political); the Secretary to Legislature; the Additional Director General of Police (Intelligence); the Inspector General (Security) as members to inspect and suggest various options for locating the Legislative Assembly, Legislative Council and allocation of Residential Quarters to Hon'ble Ministers and Hon'ble MLAs and MLCs belonging to both the successor States. The Committee inspected the premises of Legislative Assembly, Legislative Council, Chief Minister's Camp Office-cum-Residence, Quarters of Ministers, MLAs and MLCs, and submitted alternative options for consideration of the Government.
- 4. The Government, after careful examination of the proposals and other facets of the matter, hereby allocate provisionally the buildings in Greater Hyderabad Municipal Corporation Area for Legislative Assembly, Legislative Council, Camp Office-cum-Residence of Chief Minister, Residence of Ministers, MLAs and MLCs of the successor States of Andhra Pradesh and Telangana, as per the notification summarized below.

5. Accordingly, the following notification will be published in the extraordinary issue of Andhra Pradesh Gazette, dated: 30-5-2014:

NOTIFICATION

In pursuance of powers conferred under section 5 of the Andhra Pradesh Reorganisation Act, 2014 (Central Act No.6 of 2014) and all other powers hereunto enabling, the Governor of Andhra Pradesh hereby allocate provisionally the buildings in Greater Hyderabad Municipal Corporation Area for the Legislative Assembly, Legislative Council, Camp Office-cum-Residence of Chief Minister, Residence of Ministers, MLAs and MLCs of the successor States of Andhra Pradesh and Telangana with effect from the Appointed Day of June 02, 2014, as indicated below:

- (i) New Assembly Buildings along with adjacent Ministers' Rooms and Committee Halls to the State of Telangana;
- (ii) Old Assembly Building along with adjacent Ministers' Rooms and Committee Halls to the State of Andhra Pradesh;
- (iii) Existing Legislative Council Building to the State of Andhra Pradesh; and the Jubilee Hall as the Legislative Council for the State of Telangana;
- (iv) Lake View Guest House as the Camp Office-cum- Residence of the Chief Minister of the State of Andhra Pradesh;
- (v) The existing Chief Minister's Camp Office-cum-Residence at Begumpet as the Camp Office-cum-Residence of the Chief Minister for the State of Telangana;
- (vi) Quarters Nos.1 to 15 situated at Road No.12, Banjara Hills, Hyderabad, for the residence of the Ministers of the State of Telangana; and Quarters Nos.16 to 30 for the residence of the Ministers of the State of Andhra Pradesh;
- (vii) 11 to 19 Blocks (9 General) and 20 to 23 (4 Deluxe) at Adarsh Nagar and the Multi-Storied Block MS1 at Hyderguda are allotted for the purpose of residential accommodation for the MLAs of the State of Andhra Pradesh.
- (viii) 1 to 10 Blocks, 24th Block (Deluxe 3-Storied Building) and Doctors' Quarter (2-Storied Building) at Adarsh Nagar and Multi Storied Block MS2quarters are allotted for the purpose of residential accommodation to the members of Legislative Assembly of the State of Telangana.
- 6. The Special Chief Secretary to Government (Accommodation) and the Secretary to Government (Political), General Administration Department, and the Secretary to Legislature shall take necessary action and arrangements as per the transition plan.
- 7. The issues relating to deviations, if any, in allocation of office space between the two States shall be resolved amicably by the Special Chief Secretary / Principal Secretary / Secretary to Government concerned in consultation with the Head of Department. If the same cannot be resolved at their level, the matter shall be referred to the State Apex Coordination Committee being established for redressal.
