The Secretary of the Legislative Departmentshall relieve the employees mentioned in the Annexure immediately, with a direction to report before the Secretary of the concerned department of the State of Telangana. The concerned Secretary shall verify the entries in the Service Register and record a service verification certificate in the Service Book of the Employees. The Secretary of the TelanganaLegislative Department shall inform the joining details of the employee to the State Reorganisation Departments of the States of Andhra Pradesh and Telangana.
- 6. The following Notification shall be published in the Gazette of Andhra Pradesh.
