The attention of the Directors of Health, Government of Andhra Pradesh and Government of Telangana is invited to the references cited, and they are informed that the Government of India drawing powers conferred under U/s 77(2) of AP Reorganisation Act, 2014 allocated all the State cadre employees of the Director of Health who immediately before 2.6.2014, were working in connection with the affairs of Government of Andhra Pradesh, to their respective States, with effect from 2.6.2014. The list of employees allocated to AP and TS are available in DOPT site which can be accessed at http://dopt.gov.in.

- 2. Further, the Directors of Health of Andhra Pradesh and Telangana State are informed that in the reference $1^{\rm st}$ cited, it was clarified that the following categories of Tentatively allocated employees are not to be relieved till final allocation orders are issued by the Government of India.
 - a) The Tentatively allotted employee who is aggrieved by his/her Tentative allotment and represented within the prescribed period of two weeks from the date of publication of notification against his/her tentative allocation.
 - b) The Tentatively allotted employee against whom there are objections made within the prescribed period from the date of publication of notification on his/her tentative allotment.
 - c) Only those representations /objections received within the prescribed period of two weeks from the date of publication of the notification to be considered in respect of the above two categories of cases for withholding the relief of the tentatively allotted employees.
- 3. The Directors of Health of Andhra Pradesh and Telangana State are informed that now the Government of India has issued final allocation orders in respect of State Cadre employees of Director of Health. They are, therefore, directed to relieve employees to their respective States as per Final allocation list of State Cadre employees of Director of Health issued by the Government of India.
