Sub: A.P.Reorganisation Act 2014- Allocation of employees of State Services Employees- Publication of Provisional Notifications of cadre Strength– Online submission of official views/remarks of the respective Departments of Secretariat/Heads of the Departments on the comments / representations submitted on line - Reg.

Cadre strength of posts as on 1st June, 2014, and its proposed allocation (state cadre posts as well as local cadre posts for which personnel are drawn on tenure basis from local cadres) between the States of A P and Telangana are being notified calling for comments /suggestions on reorganization web site (<http://reorganisation.ap.gov.in>) for different departments, in groups, as and when received from the Departments in accordance with the Guidelines Relating to Allocation of State Services Employees.

It has been requested in the notifications that all the concerned may submit comments and representations if any regarding the cadre strength and its proposed distribution pertaining to any Department in electronic form using the online facility available on the reorganization website within 10 days from the date of the publication of the Notification

The departments concerned will be required to submit their official remarks on the representations and comments if any received in respect of the Department in the web site 'reorganisation.gov.in". All the Departments of Secretariat / all the Heads of the Departments are therefore requested examine the comments / representations filed by employees and associations etc., online in respect of their departments against any category of post or posts etc., keeping in view the law, rules, and orders and shall submit official remarks against such comments/ representations, filed by employees and associations etc., in electronic form through reorganization website within 5 days, from the date of the completion of stipulated period of 10 days time for submission of comments / representations by all the concerned, in respect of their respective department. The necessary functionality is provided in the reorganisation website for all the HODs/Secretariat Depts.

After submitting official remarks on the comments/ representations online, all the departments of Secretariat and Heads of the Departments are requested down load their official remarks and submit with the authentication by the concerned Head of the Department to G.A (SR) Dept immediately.

This may be treated as top priority.
