Section 80(1) of the Andhra Pradesh Reorganisation Act, 2014 (No.6 of 2014) envisages that the Central Government may, by order, establish one or more Advisory Committees for the purpose of assisting it in regard to:

- (a) the discharge of any of its functions relating to services; and
- (b) the ensuring of fair and equitable treatment to all persons affected by the relevant provisions under the Act and proper consideration of any representations made by such persons.

2. Vide reference 3<sup>rd</sup> read above, the Government of India has envisaged the constitution of a State Reorganisation Cell to act as the Nodal Office for coordinating matters relating to State Services, including rendering assistance to the State Advisory Committees.

3. Accordingly, the Government, after careful examination, hereby constitutes the State Reorganisation Cell with the following members:
