Sub:- Andhra Pradesh Reorganisation Act 2014 - Tentative allocation lists of State Cadre employees - Relieving the employees working in one State tentatively allocated to the other State - Clarification - Reg.

Notifications are being issued publishing tentative allocation lists of State Cadre employees as and when the Advisory Committee drew up the tentative allocation lists of departments from time to time. It is indicated in the Notifications issued publishing tentative allocation lists that an employee who feels aggrieved by his/her tentative allocation shall submit his/her representation on-line and in ink signed hard copy against his/her allocation to the Head of the Department of the State in which he is serving within two weeks from the date of publication of the notification.

2. The Government of India, in their letter second cited, directed the State Governments of Andhra Pradesh & Telangana to issue orders "relieving those employees against whom no objection has been raised", to that State as allocated in the tentative allocation list, pending issue of final allocation orders by Central Government.

3. After completion of 14 days time given for filing representations by employees aggrieved by tentative allocation, the Departments of Secretariat concerned are being requested to take immediate necessary action for issuing individual orders relieving those employees working in one State tentatively allotted to the other State as per the directive of Government of India mentioned in para (2) above in respect of the tentatively allotted employees of the departments under their administrative control.

4. Several enquires are being made from several Departments of Secretariat and Heads of the Departments seeking clarifications who are to be relieved and who are not to be relieved considering the objections relieved and the directive of

Government of India on the tentative allocations of employees of several departments made by the Advisory Committee.

5. It is clarified that the following categories of tentatively allocated employees are not to be relieved till final allocation orders are issued by Central Government:

- a. The tentatively allotted employee who is aggrieved by his/her tentative allotment and represented within the prescribed period of two weeks from the date of publication of notification against his/her tentative allocation.
- b. The tentatively allotted employee against whom there are objections made within the prescribed period from the date of publication of notification on his/her tentative allotment.
- c. Only those representations/objections received within the prescribed period of two weeks from the date of publication of the notification to be considered in respect of the above two categories of cases for withholding the relief of the tentatively allotted employees.
