The Andhra Pradesh Reorganisation Act, 2014 – Provisional allocation of Blocks for the Secretariats to the successor States of Andhra Pradesh and Telangana and also office space in the Blocks to the Departments of Secretariat of the respective States – Orders – Issued.

ORDER:

1. In the Gazette first read above, the Government of India have notified the Andhra Pradesh Reorganisation Act, 2014 (Act No.6 of 2014). In the Gazette second read above, in exercise of the powers conferred by Section 2(a) of the said Act, the Central Government have notified 2nd day of June, 2014 as the Appointed Day for the purposes of the Act.
2. As per Section-5 of the Andhra Pradesh Reorganisation Act 2014(Central Act No.6 of 2014), on and from the appointed day, Hyderabad (Greater Hyderabad Municipal Corporation Area) in the existing State of Andhra Pradesh shall be the common capital of the State of Telangana and the State of Andhra Pradesh for such period not exceeding 10 years. Accordingly the Secretariats of both the successor States have to be located in Hyderabad in the available Government premises and buildings.
3. Government, after careful consideration of the matter, hereby allocate provisionally the A, B, C and D Blocks in the existing Secretariat premises for the Secretariat of the State of Telangana; and J, K, L, H(South) and H(North) Blocks, for the Secretariat of the State of Andhra Pradesh, for the purpose of locating the respective Secretariats.
4. Government further allocate provisionally the office space to the Departments of Secretariat of the States of Telangana and Andhra Pradesh, as indicated in Annexures-I & II respectively, appended to this order.
5. Accordingly, the following Notification shall be published in the extraordinary issue of Andhra Pradesh Gazette, dated: 30-5-2014:

NOTIFICATION

In pursuance of Section-5 of the Andhra Pradesh Reorganisation Act, 2014 (Central Act No.6 of 2014) and all other powers hereunto enabling, the Governor of Andhra Pradesh hereby order for provisional allocation of the A, B, C and D Blocks in the existing Secretariat premises for the Secretariat of the State of Telangana; and J, K, L, H(South) and H(North) Blocks, for the Secretariat of the State of Andhra Pradesh. Consequently, it is also ordered for allocation of office space to the Departments of Secretariat of the States of Telangana and Andhra Pradesh, as indicated in the Annexure-I & II respectively appended to this Notification. The said allocation shall come into force with effect from June 2, 2014.

6. All Secretariat Departments shall take necessary action and arrangements as per transition plan.

7. The issues relating to deviations, if any, in allocation of office space between the two States shall be resolved amicably by the Special Chief Secretary / Principal Secretary / Secretary to Government concerned. If the same cannot be resolved at their level, the matter shall be referred to the State Apex Coordination Committee being established for redressal.
